SEWAGE RATES

AVAILABILITY

This rate is available to a customer for providing domestic and commercial sewage facilities.

RATE PER MONTH WHERE WATER IS METERED

The normal use of kitchen, bathroom and laundry fixtures per family unit for single residence or multiple family dwellings:

RATE PER MONTH WHERE WATER IS UNMETERED

For mobile homes or trailers.....	\$ 43.90
For single family unit - minimum charge shall be.....	\$ 43.90

NEW ACCOUNT CHARGE

A \$25.00 new account charge will be applied to new customers taking service in new or existing homes. This charge will be waived if sewer customer is also a water customer within the same service area.

DEPOSIT

A \$15.00 deposit is required and will be returned at the time of termination. This amount is exclusive of the deposit required for water service.

CONNECTION CHARGES SHALL BE AS FOLLOWS:

- (1) Single family residence.....\$700.00
- (2) Mobile homes or trailers, per unit.....\$265.00
- (3) Multiple family dwellings located outside Bel Air,
per family unit, first family.....\$491.00
each additional family unit.....\$265.00
- (4) Road cut charge: will be added to connection
charges if a road cut is required. (See Note 1).\$180.00
- (5) Road crossing charge: will be added to connection
charges if a road crossing is required. (See Note 1).\$325.00

Note 1. If water and sewage connections are made at the same time, a single road cut charge or road crossing charge will be imposed.

TERMS OF PAYMENT

Bills for metered and unmetered service will be rendered monthly or bi-monthly, at the Company's discretion and are payable on presentation and are net. If not paid within 15 days after date of bill, a penalty of five percent (5%) will be added to the net bill and service may be discontinued after five (5) days written notice.

BAD CHECK CHARGE

If a check is returned by a customer's bank for insufficient funds or any other reason, a bad check charge of Twenty Dollars (\$20.00) will be imposed upon the customer, and shall be due and payable immediately. (One charge per check each time it is returned).
